The bids with all complete documents will be evaluated as under.

- 1. All bidders are required to submit filled, correct, complete and signed/stamped Annexure III Technical Requirement Document along with their TECHNICAL PROPOSAL. If the bidder fails to do so, its bid will be considered as rejected.
- 2. If any bidder mentions propose solution financial details (i.e. price, cost etc.) and/or Bid Security amount in its TECHNICAL PROPOSAL, its bid will be considered as rejected.
- 3. For evaluation purpose, a desired response of only 'Y'/'Yes' or 'N'/'No' is required in the "Availability Response" column for all requirements (mentioned in Annexure III Technical Requirement Document).
- 4. All requirements with "High" Priority must be answered as 'Y'/'Yes'. If bidder responds 'N'/'No' against any of the "High" Priority requirement, its bid will be considered as rejected.
