Objective and Scope

The scope of work includes but not limited to preparation of tender advertisement / Expression of Interest by suggesting an appropriate method and procedure of procurement keeping in mind an individual procurement complexity of each project and NBP timelines. In addition to this, mainly the consulting firm shall be responsible for developing Request for Proposals, generic specifications of required I.T. Products and Services, bidder qualification requirements, technical evaluation matrix, bill of quantity and also responsible to perform technical and financial evaluations of assigned projects by submitting their findings / observations and recommendations in the form of a report to NBP in a transparent manner in compliance with PPRA and NBP Procurement rules.

Furthermore the consulting firm will have to develop templates of agreements and notes for submission to the management.

The contract shall be awarded for 02 years from the date of project award.

Expression of Interest shall be submitted in two separate envelopes, one marked ORIGINAL and one marked COPY and must be delivered to the address below not later than June 27, 2013 till 05:00PM.

Shortlisted firms who will qualify the stated eligibility criteria will be contacted for submission of Technical and Financial Proposal. Pursuant to Regulation- 3(B) Methods of Selection of Consultants of "Procurement of Consultancy Services Regulations, 2010" of PPRA; Quality and Cost Based Selection will be adopted for the selection of consultant.
