# **Invitation to Bids**

- 1. This Invitation to Bids follows the Procurement Notice for the subject Project/Procurement which appeared in Newspapers and on **NBP** and **PPRA** Websites.
- The National Bank of Pakistan has reserved the funds for the procurement planned during the financial year 2025. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the aforesaid procurement.
- 3. The National Bank of Pakistan; now invites bids from eligible Suppliers for Procurement of Floor Standing & wall Mounted Air-Conditioners with related Services; **through EPADS only.**


