## "Supply & Installation of Diesel Generator Set"

National Bank of Pakistan (NBP) intends to invite bids on item rates basis for following works from reputable firms:

 Supply & Installation of 25 (Twenty-Five) Units of 20 KVA Prime Rating Diesel Generator Sets throughout Pakistan

This is **Single Stage- Single Envelope bidding procedure** as per rule 36 (a) of PPRA rules 2004. Bidding documents containing detailed terms and conditions, method of procurement, procedure of submissions of bid, bid security, bid validity, opening of bid, evaluation criteria, bill of quantity, services technical requirements, clarification / rejection of bids etc. can be obtained from the office of Divisional Head-Procurement Division, 3rd Floor, NBP Head Office, I.I. Price of the bid bidding document is Rs. 1500/- (non-refundable) which will be in form of Pay order / Bank draft in favor of National Bank of Pakistan. The bidding documents will be issued after scrutiny of following documents provided by the bidders:

- Written application on Company's letterhead for issuance of bidding documents
- Company Profile with complete detail of works in hand.
- Banker's Certificate credit worthiness of firm with Bank.
- Provincial / FBR Tax Registration Certificate of Income & Sales Tax. Name of Bidder must appear on Active Tax Payers List of FBR
- After Sale Services, maintenance equipment and skilled manpower.
- Affidavit that the firm has never been blacklisted by any GOP /Semi Govt. or Autonomous Bodies.
- List of any arbitration / dispute with any client present or past and nature thereof.
- List of generators of 20 KVA Prime Rating & above with name of clients.
- Copy of Dealership certificate from OEM.
- Copy of valid Registration with PEC (with relevant Specialized Field).

Sealed bid accompanied with Bid Security (as per PPRA rule 25) in a form of Payment Order/CDR in favor of NBP in sealed envelope, prepared in accordance with bidding documents, must reach at the <u>Divisional Head Office, Procurement Division, 3rd Floor, NBP, HO Building Karachi.</u> on or before 03:00p.m., 24<sup>th</sup> December, 2021. The bids will be opened the same day publicly at 03:30p.m. in the presence of Tender Opening Committee and bidder's representatives who opt to attend. If office remains closed for any reason, the tender will be opened on next working day at same time and place. For clarification to the prospective bidders, a Pre-Bid Meeting is schedule to be held in the same office on **December 08**<sup>th</sup>, 2021 at 03:00 p.m.
