This is a “Single Stage-Two Envelope Bidding Procedure” as per Rule 36 (b) of Public Procurement Rules 2004 under PPRA. Separate bidding document will be issued for each lot in respective region. Bidding document, containing detail terms and conditions, method of procurement, procedure for submission of bids, bid security, bid validity, opening of bid, evaluation criteria, bill of quantity, services technical requirements, clarification/rejection of bids, performance guarantee etc. can be obtained from Wing Head Procurement (Central) NBP, RHQ Building, 26-Mcalgon Road, Lahore on any working day before **05th April, 2022** after submitting / deposit of price of Rs.1000/- for each separate bidding document of each separate category (Non-refundable) which will be paid in form of a pay order in favor of National Bank of Pakistan (NBP). The Bidding documents will be issued after checking / scrutiny of following documents provided by the bidders;

- Written application on Company’s letterhead for issuance of bidding documents with intended category of generators and names of branches and offices for which tenders have been requested.
- Company Profile with complete detail of works in hand.
- Performance certificates of quoted brand as well as documentary evidence/supporting documents of offered technical specifications of quoted brand from principle.
- Banker’s Certificate - credit worthiness (Rs.10 Million) of firm with Bank.
- Provincial / FBR Tax Registration Certificate of Income & Sales Tax. Name of Bidder must appear on Active Tax Payers List of FBR.
- After Sale Services, maintenance equipment and skilled manpower with warehouse Availability at least in five big cities.
- Affidavit on legal stamp paper (original) that the firm has never been blacklisted by any GOP /Semi Govt. or Autonomous Bodies.
- Copy of valid Dealership Certificate from OEM.
- List of any arbitration / dispute with any client present or past and nature thereof.
- Copy of valid Registration with PEC (with relevant Specialized Field).
- Bid Validity period 180 days

A pre-bid meeting will be held at 11:00 AM on 24th March, 2022 at given address. Sealed bids accompanied with bid security (as mentioned in tender document) in the form of pay order / CDR in favor of National Bank of Pakistan in sealed envelope, prepared with in accordance with bidding documents, must reach at Wing Head Procurement (Central) NBP, RHQ Building, 26-Mcalgon Road, Lahore on or before **11:00 AM, 05th April, 2022**.
