- c) The bidder should have completed at least two similar projects of Banks, Financial Institutes or Multinational Companies, costing not less than **Rs. 4.0 Million** during last **five (05) years**.
- d) The bidder should **not have been blacklisted** and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration by any Organization / Department / Institution.
