INVITATION TO BIDS

National Bank of Pakistan (NBP), one of the largest commercial banks operating in Pakistan, invites sealed bids from the original manufacturers / authorized distributors / suppliers/ Contractors, registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of Federal Board of Revenue for:

• Supply & Installation of Air Conditioning Units of 1.5 Ton Capacity (04 Nos.) & 1 Ton Capacity (04 Nos.) for NBP Latifabad No.08 Branch (0091), Hyderabad Region.

Eligibility criteria for bidding document consists of the following.

- 2. Copy of valid NTN / STN certificates and bidder must be on active tax payer list of FBR.
- 3. Bidder must have two supplies of Air conditioning of each worth One (01) Million or above during last three (03) years.
- 4. Copy of Valid dealership certificate from OEM.
- 5. Affidavit on stamp paper of Rs. 100/- that the firm has not been blacklisted in past by Govt./ Semi Govt./ Private Organizations.

All the interested bidders, who wish to participate in the bidding, must submit the documentary proof of above-mentioned eligibility criteria in the office of the Divisional Head, Procurement Division, 3rd Floor, NBP Head Office, Karachi, for verification on or before July 05, 2023. In case of non-compliance / ineligibility the bidder will not be allowed to participate in the bidding process.
