
Invitation to Bids

- 1. This Invitation to Bids follows the appeared on **NBP** and **PPRA** Websites.
- The National Bank of Pakistan has reserved the funds for the procurement planned during the financial year 2024. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the aforesaid procurement.
- 3. The National Bank of Pakistan; now invites bids from eligible Suppliers for Procurement of Floor Standing Air-Conditioners with related Services; **through EPADS only.**
- 4. The bidding shall be conducted in line with the Single Stage One Envelope procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time), and is open to all potential bidders.
- 5. All bids must be accompanied by a scanned Copy of Bid Security in the form of Banker's Cheque or Payment Order or Bank Guarantee in the amount of **RS. 200,000/-.** The ORIGINAL BID SECURITY MUST be submitted to the National Bank of Pakistan any time before the Closing time of Bid Submission, failing which the bid shall be rejected.

The original bid, along with all the required documents as stated in the bidding documents; properly filled in, must be submitted ONLY through e-Pak Acquisition & Disposal System (EPADS) at or before 11:30 am dated: 06 August, 2024. 1. Scope of Bid	1.1	The Procuring Agency (PA), as indicated in the Bid Data Sheet (BDS) hereinafter

3. Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public
		agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture,
		consortium, or association. In the case of a joint venture, consortium, or
		association, all members shall be jointly and severally liable for the execution of






