1. INTRODUCTION

National Bank of Pakistan (NBP), invites Expression of Interest for the procurement of consultancy services of a well reputed & technically sound Consulting firm for aforesaid works as per PPRA's Procurement of Consultancy Service Regulations 2010

2. OBJECTIVES AND SCOPE OF SERVICES.

The Objectives of the Consulting Firm are:

- a) To Plan, Design, Preparation of Bidding Documents & Bidding Process etc. of the proposed Construction works of NBP Branches and Regional Offices
- b) To supervise in detail, the Execution of Construction works & Verification of Contractor's Bills as per actual work done at site of NBP Branches and Regional Offices

3. **ELIGIBILITY/ EVALUATION CRITERIA**:

- Consultancy Firm should have valid Firm Registration with Pakistan Council of Architects and Town Planners (PCATP) & Pakistan Engineering Council (PEC) as well as registered in SECP.
- 2. Consultancy Firm should have completed two projects of similar nature costing not less than 150.0 Mn. each during last five years on the date of submission of proposal (Award and Completion of Works documents).
- 3. Consultancy Firm should be registered with FBR & Relevant Provincial Revenue Authority on date of submission of proposal and is on ACTIVE Taxpayer Lists.
- 4. Consultancy Firm should have in house capability of Architectural, Structural, MEP designing and site execution works departments etc. under supervision of well experienced Architects, Structural and Resident Engineers.
- 5. Consultancy Firm have to submit an undertaking on e-stamp paper that the firm has never been black listed by any government / non-government department / organization.

4. GUIDELINES FOR SUBMISSION OF EOI.

In order to qualify for the next stage, the Consulting Firms must meet the above stated eligibility / Evaluation criteria. The Consultancy Firm fulfilling the above defined criteria are requested to







submit their Expression of Interest along with necessary documents (including confirming their compliance to above stated eligibility criteria list.)

The Proposals, prepared in accordance with the "Expression of Interest" must be submitted on EPADS (PPRA website) by June 25, 2024 at 02:00 PM, the same will be opened on same day at 02:30 PM in the presence of procurement Committee and the representatives of Firms who wish to be participated.

Shortlisted firms qualifying as per above stated eligibility criteria will be contacted for submission of Technical and Financial Proposals pursuant to Regulation-3 (C) Method of Selection of Consultants "Procurement of Consultancy Services Regulation 2010" of PPRA "Least Cost Method" will be adopted for the selection of Service Provider.
